Fleet Services Supervisors who have qualified in a departmentally approved course certified by the CA State Fire Marshall on aerial ladders and pumps unique to fire apparatus equipment, or that are continuing their education in a departmentally approved course of study on equipment unique to fire apparatus shall receive certification pay of 5%. The department head shall approve no more than two Fleet Services Supervisors at any one time to receive the 5% certification pay as outlined in this paragraph.
